04.	Warranty	A Standard Warranty of 01 (one) year will be applicable. During this period, the vendor shall repair any kind of defects including replacement of any parts at their own cost.	
05.	Inspection	Signing of the delivery receipt of any goods & services by different branches/offices shall not be count as acceptance to Prime Bank. Prime Bank has the right to carry out inspections and tests if seems not fit to quality of conformance of the goods & services in that case supplier shall provide all reasonable assistance free of charge.	
06.	Payment	Payment will be made within 30 (Thirty) days from bill receipt and payment will be made as per the following manner: a. In case of bill amount/ work order amount at a time over Tk. 2,00,000, 90% of the unit price will be paid after satisfactory installation of the equipment. b. Remaining 10% of the unit price will be paid after covering warranty period from the date of products delivery.
