Interested vendors are requested to submit their financial quotations along with technical specifications on their official letterhead, duly signed and sealed, in accordance with the terms and conditions outlined in this RFQ.

Eligibility and other conditions:

1. Rate Contract Period:

Prime Bank will maintain a panel of suppliers to provide event-related services for a period of six (06) months, which may be extended. The panel will be selected based on common fixed rates approved by the Bank.

2. Pricing and Taxation:

The quoted rates must be exclusive of VAT but inclusive of AIT and all other applicable charges. No additional transportation costs will be paid. AIT will be deducted at source as per government regulations.

3. Mandatory Document Submission:

Bidders must submit photocopies of the following documents along with the RFQ:

- Up-to-date Valid Trade License
- Certificate of Incorporation (for Limited Companies)
- Valid TIN and BIN Certificates
- VAT Registration Certificate
- Bank Solvency Certificate
- Experience Certificate/Work Orders
- List of Employees (related to design and creative works)
- Client List

(Incomplete or improper documentation may result in technical disqualification.)

4. Experience Criteria:

- A minimum of **five (05) years** of experience in creative and design work is required. A copy of the oldest Trade License must be submitted as proof.
- At least three (3) work orders or invoices from three different clients, executed within the last six (6) months, must be submitted.

5. Disqualification Clause:

Vendors with any prior negative experience with Prime Bank PLC will be disqualified. Their financial offers will not be considered or opened.

6. Integrity and Submission Compliance:

Any submission containing false information, data tampering, manipulation, or failure to meet the submission deadline will lead to automatic disqualification.

7. Quality Assurance:

In the event of delivery of **inferior quality goods or services**, the supplier must make immediate replacements or modifications as requested by Prime Bank.

The supplier must provide timely responses via phone, email, or in person to any queries from the Bank.

Any attempt to influence the evaluation process will result in immediate disqualification.

The name, address, email and telephone number of the contact person should be mentioned in the forwarding letter both of the "Technical Offer" and the "Financial Offer".
