- b. Provide a Company profile along with a completed project (minimum 03) picture with company/Bank name and Company organogram.
- c. Should have work experience in executing relevant types of work for a minimum amount of Taka 50 Lac or above in a single work order in last 2 (two) years with reference of existing client. Please submit proof of documents with work completion certificate.
- d. Provide valid Trade License/Incorporation Certificate/Ownership Document, BIN, TIN Certificate & Bank Solvency Certificate.
- e. The Following Technical Personnel of the firm should meet below criteria:
 - I. **Civil Engineer (Permanent/Contractual):** Having working experience for a minimum period of 05 years in relevant field (Bachelor of Science/Diploma). Please submit proof of documents.
 - II. **Electrical Engineer (Permanent/Contractual):** Having working experience for a minimum period of 05 years in relevant field (with Bachelor of Science/Diploma). Please submit proof of documents.
- f. Vendor with previous bad record with Prime Bank PLC. will be directly disqualified. Their financial offer will not be acceptable and will not be opened. Any Fake, Tempering of Data, Manipulation or any kind of unusual approach or failure to submit the proposal/offer within the stipulated time frame will be treated as "Disqualification" to attend to the bidding.

5. **Pre-Bid Meeting** : Interested bidders shall have to attend a **pre-bid meeting** (Physical Meeting) at **Prime Bank PLC., Prime View, Plot # SE (F) 7, Bir Uttam Mir Shawkat Sharak, Gulshan Avenue, Gulshan, Dhaka - 1212** (meeting time & date mentioned as above).
6. **Earnest Money** : Earnest money (refundable to the unsuccessful bidder) equivalent to (**Earnest money % mentioned in above table**) of the quoted amount in the form of Payment Order/Bank Guaranty in favor of Prime Bank PLC. issued by any Schedule Bank shall have to be submitted along with the tender document, failing which shall cause rejection of the tender document.
